## Chao Hick Tin SC Chairman, Singapore Chamber of Maritime Arbitration

Chao Hick Tin earned his LLB and LLM from University College London in 1965 and 1966, respectively. He was called to the English Bar in 1965 and became a Bencher of the Middle Temple in 2013. Mr. Chao began his legal career in 1967 as State Counsel at the Attorney-General's Chambers and was appointed Judicial Commissioner in 1986. He became a High Court Judge in 1990, then Judge of Appeal in 1999. He served as Attorney-General from 2006 to 2008 and as Vice President of the Singapore Court of Appeal until his retirement in 2017. Mr. Chao continued as Senior Judge until 2022. He has held various leadership roles and represented Singapore in international forums.
